# May 30, 2017 Regular Session of the Beaverhead County Commissioners

The Board of Commissioners, in and for Beaverhead County, Montana, met in session on Tuesday, May 30, 2017 at 9:00 a.m. in the Commissioners' Room of the Beaverhead County Courthouse. Present: Chairman Tom Rice, Commissioner Mike McGinley, Commissioner John Jackson and Secretary Cindy Decker.

# **Updates on County Projects:**

Road Supervisor Scott Jones and Road Secretary Jamie Flynn joined the meeting. Scott asked about the Pioneer Scenic Byway and what the plan is. Russ is up there checking it out to see how bad it is.

GIS Manager Scott Marsh, Sheriff Frank Kluesner and Deputy Malkovich also joined the meeting.

Scott reported that Rock Creek Bridge is in bad shape. Discussion ensued regarding what the remedy would be. Scott will take some pictures and measure the dimensions. Jamie will also check her records.

The crew has been blading in Medicine Lodge area. They also have spread 1000 yards of "pit run" on the Minor Lake Road in the Big Hole.

Mike mentioned that there will be a Preconstruction Meeting on the Elk Lake Road next Wednesday, June 7, 2017.

Joe Walsh will be coming down sometime soon to "sign off" on the walkway at Ten Mile Road.

Tom mentioned that he would like Scott to look into Hartwig Lane where Randy Smith lives. He also asked if there is a "children at play" sign in Monida. Scott replied that yes there should be, but now that sign is gone. He will look into it. There was also discussion regarding a speed zone in Monida.

Scott Marsh brought up the fact that there are no street signs in the town of Wisdom. He advised the commissioners that 911 funding is not an option for signage. Tom asked the Sheriff and Scott to find out exactly how many street signs are needed and what the approximate cost would be. They will begin with a few of the most prominent streets and then do a few more every year.

County Attorney Jed Fitch joined the meeting.

Deputy Malkovich briefed the commissioners regarding the Pioneer Scenic Byway closure. Over the Memorial Weekend, there were 60 vehicles at Crystal Park on Monday and 22 campers up past the closures without any regard for safety. It has been very frustrating. The "road closed" sign on the Wise River side was completely knocked down.

Jed suggested a "drive at your own risk" sign. We will just wait and see what Russ says after his trip up there.

On this 30 day of \_\_\_\_\_\_\_\_, 2017, the parties to this Agreement; Beaverhead County, a political subdivision of the State of Montana, whose address is 2 S. Pacific Street, Dillon, Montana, and Joe Ivie, whose address is 130 Christine, Dillon, Montana 59725; do hereby agree and intend that the following described action shall occur and bind each of them to said Agreement, and make a mutual exchange of promises to accomplish the same.

Whereas, Joe Ivie is the owner of record of two parcels of property in the vicinity of Lima, Montana, which are shown on Certificate of Survey Number 1728AE, and described as Tract 1A and Tract 1B. It should be known that he owned what is now known as Tract 1A, and then acquired what is now Tract 1B, through a purchase and boundary line adjustment with the neighboring owner, as reflected in Certificate of Survey Number 1683BA; and

Whereas, in October of 2013, the parties entered an agreement which allowed the subdivision of the parcel, as shown in COS 1728AE, and in which it was intended to place a restrictive agricultural covenant on that certain property created by the division, namely Tract 1B, but that due to an error, the agricultural covenant was inadvertently placed on both parcels, Tract 1A and Tract 1B; and

Whereas, the purpose of the agricultural use restrictive covenant is to allow a subdivision of property without a subdivision review, when no building or construction on the created parcel is intended, and the use will remain agricultural only. That was the intention here, to place such a restriction on Tract 1B, the acquired portion of the property. There would have been no utility for Mr. Ivie, nor for the County, in placing such a restriction on Tract 1A. With the erroneous language in place, Mr. Ivie is unable to build on the property, as he intended, and as should have been permitted.

THEREFORE, by placing their signatures below, the parties do agree that the Restrictive Agricultural Covenant for Tract 1A of COS 1728AE, was never intended to be created, and by agreement of the parties is hereby lifted and nullified. This does not alter or affect the Restrictive Agricultural Covenant for Tract 1B of COS 1728AE, which remains in full force and effect, and was the basis by which the subdivision of this parcel occurred.

FURTHER, the parties agree and intend that this Agreement shall be recorded with the Beaverhead County Clerk & Recorder, with a reference to COS 1728AE, so that a public record of this Agreement shall be made
