**March 2020 – November 2023**

1. The Wisdom Elementary School District was ordered to close to in-person instruction on March 15, 2020, under an executive order issued by then-Governor Bullock. Districts were provided a two-week period of time during which they could remain fully closed to instruction of any kind while developing a plan for remote instruction required by the Governor.

Although our school district was authorized to remain closed, we quickly mobilized and began remote instruction during the timeframe when we were authorized to remain closed. Thereafter, our school district continued pursuant to a reopening plan approved by the Governor beginning March 30, 2020.

2. On April 22, 2020, then-Governor Bullock lifted his Stay at Home Order, and Announced a Plan to Begin Phased Reopening of Montana. As part of that plan, effective May 7, 2020, all schools were provided the option to return to in-classroom teaching at the discretion of local school boards.

Our school district finished the 2019-20 school year through remote/offsite instruction.

3. Our school district developed a plan for reopening to in-person instruction, with contingencies, and we implemented that plan for the 2020-21 school year. The reopening plan, details regarding which are provided below, included adoption of various model policies provided by the Montana School Boards Association under its 1900 Series, including model policies aligned with the Centers for Disease Control guidance regarding mitigation strategies to limit exposure to and transmission of COVID-19 in school settings.
4. Our school district reopened to in-classroom instruction during the 2020-21 school year, and was fortunate to remain open for in-person instruction for 96% of the school year. During the school year, there was a temporary closure of all in-classroom teaching pursuant to quarantine or isolation orders issued by our county department of health. Our temporary closure to in-classroom teaching was for

seven school days from October 29, 2020 – November 6, 2020. During the 2020-21 school year, our modes of operation included:

- i. In-person
- ii. Offsite

Our school district finished the 2020-21 school year strong, having provided high quality learning opportunities to the students in our community in safe and effective learning environments.

5. In June 2021, our school district crafted this Safe Return to In-person Instruction and Continuity of Services plan. In August 2021, the board of trustees declared their own unforeseen emergency to last through June 30, 2022, in accordance with sections 20-9-801 through 20-9-806, MCA, due to community and school health concerns related to COVID-19. During the 2021-22 school year, our modes of operation were:

- i. In-person
- ii. Off-site

Our district provided offsite instruction for students issued with quarantine or isolation orders, or who chose to self-quarantine or self-isolate.

6. In March 2022, the board reviewed and revised their policies regarding face coverings. Per policy 1905, face coverings as protective equipment, were declared optional as long as county transmission rates were low or moderate per the CDC COVID Data Tracker. The policy continued to be aligned with the Centers for Disease Control guidance regarding mitigation strategies to limit exposure to and transmission of COVID-19 in school settings. The county transmission rate was monitored daily. Although the transmission rate was low or moderate for the remainder of the school year, school building access continued to be limited to essential personnel only. We remained open to in-person instruction for the entire school year.
7. In June 2022, the board of trustees declared their own unforeseen emergency to last through June 30, 2023, in accordance with sections 20-9-801 through 20-9-806, MCA, due to community and school health concerns related to COVID-19.
8. In August 2022, the County Health Department provided our rural teaching staff with the latest updated CDC guidance regarding COVID-19 testing, isolation, quarantining, social distancing, and masking. This guidance helped staff to better understand the potential risks, proper protection actions to take, and what actions to take if sick or test positive for the virus.
9. In November 2022, the board of trustees aligned policy 1905 with the guidance provided to our teaching staff in August, as well as CDC recommendations.

10. On February 10, 2023, the President temporarily extended the declared national emergency for COVID-19. At that time, he concluded his announcement with a statement that the anticipated termination of the national emergency concerning COVID-19 pandemic would end on May 11, 2023.

11. Policies 1900-1912 were intended to govern during the declared emergency related to COVID-19 declared by the President, Congress, Montana Legislature, Governor, Montana Department of Health and Human Services, County Health Department, and board of trustees. With the termination of the national emergency concerning COVID-19, in April 2023, the board of trustees voted to terminate their declared emergency and temporary emergency policies numbered 1900-1912, and work with necessary stakeholders to enact their motion.

12. For the 2022-2023 school year, our mode of operation was:

- i. In-person

There were no temporary closures due to quarantine or isolation orders.

13. For the 2023-2024 school year, our mode of operation has been:

- i. In-person

There have been no temporary closures due to quarantine or isolation orders.

14. We embraced a fundamental principle of providing extensive transparency to our community throughout the above timeframe. We publicly noticed, held meetings regarding, and provided extensive opportunities for our community to provide us with feedback regarding the school district's plans and we carefully considered such feedback in developing and refining the school district's plans throughout the last 45 months.

To the extent present in or served by our school district, our invitation for public input included a general opportunity for the public to provide input and was provided to everyone interested, including:

1. Students; families; community members; county administrators (Superintendent of County Schools, county health nurse); teachers (we do not

have a union), other educators, school staff; and stakeholders representing the interests of children with disabilities (parents).

2. We are a very small rural school district with no diverse student groups. Furthermore, we do not have any tribes, civil rights organizations (including disability rights organizations), English learners, children experiencing homelessness, children in foster care, migratory students, children who are incarcerated, or other underserved students present in or served by the school district.
3. Beginning in July 2021, a standing agenda item, “Consideration of Changes to Safe Return to In-person Instruction and Continuity of Services Plan”, has been added as a means for the board of trustees to invite monthly stakeholder discussion. This will be in effect throughout the 2021-24 school years.

## **Part II: Contents of the School District’s Plan for Safe Return to In-Person Instruction and Continuity of Services:**

1. A description of how the school district will maintain the health and safety of students, educators, and other staff:

Following the lifting of the Stay-at-Home Order and subsequent reopening of the state on April 22, 2020, Wisdom Elementary School District utilized the Montana Public Education Center *Roadmap for Safely Reopening Montana’s Public Schools Using Emergency School District Policies* and accompanying MTSBA Model Emergency Policies. Utilizing these resources supported our school district’s continued service to students with transparency and accountability while ensuring the operations of the school district reflected the circumstances in our community.

The policies ensured our board of trustees and school leaders honored the following priorities: quality instruction to students; a healthy and safe setting for students, staff, and the community; needed support of teachers and staff; and responsible financial and operational procedures. The policies provided an actionable plan for completing the 2019-20, 2020-21, 2021-22, and 2022-23 school fiscal years in a manner that met these priorities and secured school district funding while providing an operational platform for considering long term innovations in the delivery of education services.

Wisdom Elementary School District implemented policy options that facilitated collaboration between the board of trustees, staff, employees, parents, students, health officials, and community as we established protocols aligned with CDC guidance addressing how instruction was to be delivered to students; how gatherings and events would take place on school property; how the health and safety of staff and students would be protected and preserved while school was open; and how financial and operational functions of the school district would continue during the period of public health emergency.

Wisdom Elementary School District reviewed, considered, and addressed numerous areas of operation in our reopening process. On the topic of school district policy and procedures, the school district considered emergency policies and procedures, adoption and amendment of policies, suspension of policies, and administrative procedures. To support students' academic, mental, social and emotional success, the school district considered alternative grading, counseling, extended school year, student instruction proficiency determinations and declarations, support for particularly vulnerable students, access to internet for students, food preparation, summer school and additional student instruction resources. To ensure the health and safety of students, teachers, and staff, the school district considered cleaning and disinfection, community use of facilities, county board of health orders, diagnosis and confidentiality, hand washing and related hygiene protocols, telework, school closure orders, stay at home orders, symptom monitoring and isolation, travel quarantines, visitors, volunteers, vulnerable individuals, masks and personal protective equipment, and physical distancing.

Following the *Roadmap for Safely Reopening Montana's Public Schools Using Emergency School District Policies* ensured Wisdom Elementary School District has remained in compliance with guidance and best practices provided by federal, state, or local health officials. Our school district has continued to adapt and adjust our policies as new and updated guidance and best practices have become available.

Further, the policies provide options for consideration through input from our board of trustees, administrative team, employees, parents, students, health officials, and community as collaborative partners as we have worked our way through ever evolving changes due to the pandemic. By considering all possible perspectives and factors when making the decisions to adopt or adjust a policy, or to implement a policy, we focused on the health and safety of our students, staff, and community for delivery of learning and services to our students. The policies have enabled us to adjust our procedures and practices during different phases in compliance with guidance and best practices provided by federal, state, and local agencies.

Wisdom Elementary School District followed their temporary emergency policies for most of the 2022-2023 school year (9½ months). The district will continue to follow the policies below for the remainder of the 2022-23 school year (2½ months). We will engage in a semiannual reevaluation process of this Safe Return to In-person Instruction and Continuity of Services Plan to continue to ensure the health, safety and well-being of our students, teachers, staff, and community throughout the 2021-24 school years.

### **Part III – Updated Compliance for the School District’s Previously Adopted Plan for the Safe Return to In-person Instruction and Continuity of Services:**

Section 2001(i)(3) of the ARP Act states that a school district that developed a plan for the safe return to in-person instruction and continuity of services prior to the date of enactment of the ARP Act will be deemed to have met the requirement to develop a plan under section 2001(i)(1) as long as the plan meets the statutory requirements (*i.e.*, is publicly available on the LEA's website and was developed after the LEA sought and took into account public comment).

The school district’s plan meets the requirements of Section 2001(i)(1) and (i)(2) of the ARP Act. The school district’s plan is available through the Office of Public Instruction’s website, as well as a MTSBA-hosted website and, as noted above, was developed through a process that included extensive public comment. Further, we have, as part of the organization of the school district’s plan for purposes of the ARP Act, revised the school district’s plan at a meeting held on June 7, 2021, that included, not just a notice of opportunity for public input, but which specifically invited meaningful consultation with and input from, to the extent present or served by the school district:

Students; families; community members; county administrators (Superintendent of County Schools, county health nurse); teachers (we do not have a union); other educators; school staff;; and stakeholders representing the interests of children with disabilities (parents). We are a very small rural school district with no diverse student groups. Furthermore, we do not have any tribes, civil rights organizations (including disability rights organizations), English learners, children experiencing homelessness, children in foster care, migratory students, children who are incarcerated, or other underserved students present in or served by the school district.

We considered the input of all affected parties and carefully deliberated regarding the best possible means by which our school district could provide safe effective learning environments for each of our students.

### **Part IV – Schedule for Future Review and Updates:**

Consideration of this Safe Return to In-person Instruction and Continuity of Services Plan has been added as a standing agenda item on each regular and special meeting of the board of trustees since July 2021 and will remain so throughout the 2021-24 school years. The agenda item shall, at a minimum, include notice of any changes to the plan recommended by the board of trustees

with an invitation for input, notice of opportunity for public input, and consultation with, to the extent present or served by the school district:

Students; families; community members; county administrators (Superintendent of County Schools, county health nurse); teachers (we do not have a union), other educators, school staff; and stakeholders representing the interests of children with disabilities (parents). We are a very small rural school district with no diverse student groups. Furthermore, we do not have any tribes, civil rights organizations (including disability rights organizations), English learners, children experiencing homelessness, children in foster care, migratory students, children who are incarcerated, or other underserved students present in or served by the school district.

Wisdom Elementary School District will continue to follow their policies while engaging in a semiannual reevaluation process to continue to ensure the health, safety and well-being of our students, teachers, staff, and community throughout the 2021-24 school years. The next scheduled review will be May 2024 (if required).
