Discussion- Kelly Proffitt, FWP, regarding HB 648

Present Coty Calvin, Jim and Nancy Mayne, Casey Elliott, Warren Hansen, Tracy Sawyer

Warren Hansen, Montana FWP, joined the Commissioners via Teams to discuss House Bill 648 regarding predator release in the county. This bill requires FWP to inform all the Commissioners and Sheriff if they need to release a grizzly bear or black bear in our region. Releasing a black bear is rare, usually it gets euthanized. Black bears get released if they're trapped accidentally when trying to capture a grizzly in the same area. Currently they are researching black bears and catching them to collar and track. For grizzly bears, if they are trying to capture a "conflict"

grizzly bear they usually euthanize. If they release, it is usually non-conflict to mark and monitor for research. They are now legislatively required to inform them of any catch and release in our region. He asked of the commissioners how they would like to be informed of this process when It comes up.

McGinley asked where are the approved sites in Beaverhead County. Hansen answered there are county adjacent sites but not in Beaverhead County. He added that they would inform the Commissioners of any grizzly/black catch and release in the county.

Jackson commented if he can just email the Commissioners when this happens. Rice asked if they would contact the Sheriff/Dispatch to get the message across also.

Warren took down all the emails for the 3 commissioners and the sheriff. Secretary will follow up by sending the emails to FWP.

Coty questioned if this includes mountain lions and wolves. Warren added they do not have the authority to relocate a wolf or mountain lion anywhere. They can catch and collar.


He also questions the ecosystem being at capacity. Warren briefly discussed the delisting for grizzly over the last few years.
