June 30, 2025 Regular Session of the Beaverhead County Commissioners

The Board of Commissioners, in and for Beaverhead County, Montana, met in session on June 30, 2025 at 9:00 a.m. in the Commissioners Room of the Beaverhead County Courthouse. Present Commissioner John Jackson, Commissioner Tom Rice, Commissioner Michael McGinley and Commissioner Support Specialist Dana Basile.

Pledge of Allegiance

At this time, those present recited the Pledge of Allegiance aloud to begin the day.

Updates on County Projects

Road Supervisor Bob Ferris was present and reported the following. Last week some roads received Mag chloride treatment in a few areas. They will be working on cleaning up Ten Mile Road for chloride treating soon. Blading is getting done around the county. Tracy commented that he submitted the Hirschy pit information again. He is also working on CWPP and the phone system.

Justin added that summer has been busy so far for Fairgrounds.

Shonna added that there were plumbing issues with jail again. There are 26 inmates downstairs and the overload created plumbing issues. The plumber had to be called in twice this weekend. She will be on vacation later this week. The electrician got the sign up and running at public health. They helped Margot get her office moved to upstairs.

Stacey added that she is back from vacation and catching up.

Tina commented nothing to report. She starts this week officially as county planner.

Mike mentioned that it is quiet in his office. Everything has been submitted to the state for the rural schools. He is attending a federal grant monitoring session this Saturday.

Sky added the Axes Canyon meeting went well last week. There have been some updates to be discussed later. His office is prepping for office expansion. He is working on moving some of the 26 out of downstairs. He is going to investigate the contract with the plumber regarding the consistent plumbing issues in the jail. Next week the nurse starts medical check visits with inmates.

Commissioner McGinley added a comment about today being the last day of the fiscal year and closing out budgets this week.

The Commissioners are putting this ordinance in place to lower the speed limit to 35 for the duration of Bannack Days.

BJ talked to a few in the county and agreed to the Stage 1. He had some asking about wanting to light fireworks off at the M trail.

McGinley added it is already illegal in city limits to set off fireworks.

Commissioner Rice moved to approve the Resolution Proposing Stage I Fire Restrictions. Commissioner McGinley seconded. A verbal vote was taken and the motion carried unanimously. Effective immediately.

The following acts are prohibited until further notice:

Building maintaining, attending, or using a fire or campfire exceedeveloped recreation site, or improved site. 36 CFR 261.52(a).

Smoking, except within an enclosed vehicle or building, a developed recreation site, or while stopped in an area at least three feet in diameter that is barren or cleared of all flammable materials. 36 CFR 261.52(d)

Operating or using any internal or external combustion engine without a spark arresting device properly installed, maintained, and in effective working order meeting either USDA Forest Service Standard 5100-1a (as amended), or riate Society of Automotive Engineers (SAE) recommended practice J335(b) and J350(a) (36 CFR 261.52(j))

Discussion and Action- HB 643 Request for Override

Commissioner McGinley explained HB 643 regarding reimbursement for counties for costs of detaining individuals awaiting evaluation or committed by DPHHS custody. This bill was vetoed by the governor.

Asking for the Commissioners to call and send letters to ask to override that veto. This bill passed 147-3 but was vetoed by the Governor.

Commissioner McGinley moved that the Commissioners, County Attorney and Sherifs office to take action and write, email or call to veto this decision Commissioner Rice seconded. A verbal vote was taken and the motion carried unanimously...

Discussion- Headwaters Road Show

Kelly Sullivan and Brenan Hammer with Headwaters joined the Commissioners.

Kelly briefly discussed the program and what they are doing in the community. They lend small business capital and have special category loans and programs. They help with business planning and marketing planning. They do training opportunities for small businesses and leadership classes.

Brenan added they help ag businesses with finance through grants and help with writing grant applications. He is also a HUD counselor and puts on classes to assist with HUD financing and first-time home buyers. He can go out to trainings in the community as needed. He will be doing training in Dillon in September.

Kelly added information about the projects they have going on. She briefly discussed the Headwaters Tech fund. Rural economy planning grants- Mccallie school got awarded one for the new school in Twin Bridges. Dillon received one for a TED district and Urban renewal district.

Kelly added they have a lot of partners they work with and can use as needed.

McGinley questioned if the other commissioners knew why are we pay dues and how much does it cost? Kelly answers approx \$.52 per capita. We are members to have a right to be on the board. Lima does and Dillon does as well. McGinley has a seat on the board- this will pass on to someone in the county as Commissioners retire. It doesn't need to be a Commissioner but they need to appoint someone as needed.

Recess

At 12:00 noon, Commissioner Jackson recessed the meeting. At 1:30 p.m., Commissioner Jackson, Commissioner Rice and Commissioner McGinley reconvened the meeting with Assistant Dana Basile present.

Action on Previous Meeting Minutes

Discussion and Action- Budget Amendments Resolution 2025-14

McGinley briefly discussed working on the budgets and the following funds need to be amended to reflect the corrections listed in the resolution (see image below). Last year transitions within the finance office, different accounts needed editing and cleaning up bookwork were the factors involved. Descriptions of each account is listed on the resolution.

MOTION: Commissioner McGinley moved and Commissioner Rice seconded Resolution 2025-14 to Amend Budgets for Beaverhead County be approved. A verbal vote was taken and the motion carried unanimously.
